PERMANENT SECRETARY SUMMARY STATEMENT

I am pleased to present the Ministry of Sugar Industry 2016-2017 Annual Report in accordance with the General Order 1108(a).

The year saw many challenges to the industry and the Ministry. In February, Category 5 Tropical Cyclone Winston hit Fiji causing many unparalleled damages where lives were lost, properties, homes, farms and infrastructure were damaged. Another momentous change was the new financial year. This change was to concede for income generated during the financial year be collected and reflected for that particular financial year instead of carrying it forward and capturing it in the next financial year.

For the 2016-2017 financial year, a total of \$27.5 million was allocated to the industry by Government. The Ministry with the assistance of the industry institution implemented the following capital projects; Cane Planting (CPG) Grants - FSC, Fertilizer Subsidy Grants -SPFL, Mechanical Harvesters and Cane Access Road (CAR) Program – FSC.

In addition, operational grant was provided to Sugar Research Institute of Fiji (SRIF), Sugar Industry Tribunal (SIT) and Sugarcane Growers Council (SCGC) for their administrative cost to enable them to continue improving service delivery to the industry.

During the year, under the CPG program, total of 4298ha of cane was planted; fallow land 3366ha and replanting of 932ha. 452,983 bags of Fertilizer were supplied to farmers and a total of 3,323 kilometers of cane access roads were upgraded.

Furthermore, in 2016-2017 season a total of 1.39 million tonnes of cane were harvested.

He continued in this position after the creation of a Ministry for Sugar Industry in June 2011 at the Sugar House, Lautoka.




Figure 1: Ministry Organization Structure

Figure 3: Percentage Break Down Of Staffing Within the Ministry





Figure 4: Staff Establishment Based On Gender

2.5 Staff Training



OUTPUT 1: MONITORING & EVALUATION OF SUGAR INDUSTRY REFORMS

1.1 Monitoring of the Sugar Industry Strategic Action Plan 2013-2022

The Ministry is mandated to facilitate and oversee the implementation of reforms in the sugar industry. It monitors the implementation of the six areas of focus of the Sugarcane Industry Strategic Action Plan 2013-2022 (SAP).

Undertaking industry consultation with European Union (EU), World Bank, LMC International and Asian Development Bank (ADB)

The Ministry engaged in these consultations basically to provide updates on the status of the industry relative to the various reforms approved by Government and/or to provide clarification as to what kind of assistance the industry might want after natural disasters for which they could consider offering assistance.

1.2 Monitoring of Grant Utilization

The Ministry provided assistance to the cane growers through; Cane Planting (CPG), Fertilizer Subsidy Grants, Mechanical Harvesters and Cane Access Road (CAR) Program.

1.2.1 Cane Planting Grant Program

A budget of \$9 million was provided for assisting farmers to cultivate and plant sugarcane in fallow land as well as for replanting. This program was implemented by Fiji Sugar Corporation Ltd.

For the 2016/2017 period, the objective of this grant was to plant at least 2,000 hectares of sugarcane involving 2,100 growers. Overall, the goal was to produce a crop of at least 2.0 million tonnes of sugarcane from the 41,000 hectares with average yield of 50 tonnes per hectare in the 2017 season. The following was implemented during this 2016-2017 financial period:

1.2.2 Cane Access Road Program

The Ministry was allocated \$3million for the upgrading of the cane access road for growers to be able to deliver their cane from their cane fields to the mill for crushing. Under the Cane Access Program, a total of 2,897 roads (3,323 km) was maintained and repaired.

Moreover, culverts were issued to farmers to allow them crossing their field drainage to the main road. For 2016-2017 periods, a total of 91 culverts were issued.

1.2.3 Fertilizer Subsidy Program

The Ministry was allocated \$9.7 million for the subsidizing of fertilizer. This program was implemented by South Pacific Fertilizer Limited (SPFL) as the facilitator of this grant.

Since 2009, the Government subsidized \$14.09 per 50kg of fertilizer costing \$45.59 per bag. A total of 22,649.15 tonnes of fertilizer was delivered to farmers.



A total of sixteen (16) briefs were prepared by the Ministry.


Figure 6: Number of Briefs Submitted for the Period



2.2 Policy Matters Arising out of Farmers Complaints/Issues

The Ministry takes complaints and issues raised from growers very seriously as an important component to its service delivery. A total of 372 complaints were received from the growers. Figure 7 proves the major complaints received.

Land issue is one of the most reoccurring issues affecting the farmers as it is the core component for farming. The Ministry received 97 issues relating to lease renewal process which took longer than the required time. The request to shorten and quicken the process has led to the I-Taukei Land Trust Board (I-TLTB) to have a five year before expiry of lease term approach.

Harvesting is another major issue that is affecting the industry where farmers are finding hard to find laborers to harvest their sugarcane. The harvesting cost of laborers has also increased due to lack of labor provided in the sugar industry.

Due to the increase in harvesting issue, the Minister of Sugar Industry promised to provide mechanical harvester to farmers to harvest their cane whereas prisoners harvested canes on the hilly terrain fields where the harvester cannot operate.

Transportation tops the complaints chart whereby it is the major issue faced by farmers during harvesting season. The major issue is that many farmers have converted from rail to cane trucks hence an increase in the demand for cane delivery trucks resulting an increase in the transportation rate.

2.3 Industry Consultation with International Investors

The Ministry had eleven (11) industry consultations with international investors during the period.

Some notable visitors were:

- 1. Mr. Baskar Thambiran, Senior Manager of CNH Industrial (India) Pvt. Limited. Meeting on Mechanical Harvester in Fiji
- 2. Deputy Prime Minister of Belgium, Honorable Didier Reynders. Meeting on the Co-funding with the Fiji Government on GIS.
- 3. Mr. John Magnifico, Managing Director Solved Group for Agriculture Irrigation. Meeting on the need for Irrigation in the Sugar Industry.

2.4 International Conferences & Meeting

A delegation was led by the Prime Minister and Minister of Sugar Industry to the 25th International Seminar and 50th International Sugar Organization Council Meeting in 28 November to 2nd December.



OUTPUT 3: PUBLIC SECTOR REFORM

3.1 Improvement of Ministry Systems & Processes

3.1.1 Sugar Institution Coordination to Support Sugar Industry Reform

The Strategic Action Plan (SAP) team met to review and update on the activities on the SAP.

Some of their meeting discussions and outcome:

- i. Tropical Cyclone Winston Post Recovery Plan for the sugar industry to the government- \$163.6 million.
- ii. Industry restructuring and legislation- two draft Bills that are before the Standing Committee on Economic Affairs of Parliament.
- iii. Harvesting and Transporting- Investment in mechanized harvesters, locomotives and rolling stock and rail system; training and capacity building of technical staff and farmers.
- iv. Milling and Processing- improve sugar recovery, increase factory time efficiency and Reduce operational cost.

3.1.2 New Executive Management for Fiji Sugar Corporation Limited

A new executive management team has been recruited to oversee and steer the Fiji Sugar Corporation Limited into new heights in line with the Government's reform in the Sugar industry.

3.1.3 Continuation of Support to the Sugar Institutions

The Government continues to support the sugar institutions through various grants to assist and boost their different roles in the sugar industry. The different institutions with their supporting grants are tabulated as:

Figure 8: Women Farmers in Sugarcane District





Figure 9: New Farmers by Gender

INDEPENDENT AUDITOR'S REPORT

MINISTRY OF SUGAR INDUSTRY

I have audited the financial statements of the Ministry of Sugar Industry, which comprise the Statement of Receipts and Expenditure, Appropriation Statement and Statement of Losses for the year ended 31 July 2017, and the notes to the financial statements including a summary of significant accounting policies.

In my opinion, the accompanying financial statements are prepared, in all material respects, in accordance with the Financial Management Act, Finance Instructions 2010 and Finance (Amendment) Instructions 2016.

Basis for Opinion

I have conducted my audit in accordance with International Standards on Auditing (ISA). My responsibilities under those standards are described in the Auditor's Responsibilities paragraph of my report. I am independent of the Ministry in accordance with the ethical requirements that are relevant to my audit of the financial statements in Fiji and I have fulfilled my other responsibilities in accordance with these requirements. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.

Management's Responsibilities for the Financial Statements

The management of the Ministry is responsible for the preparation of the financial statements in accordance with the Financial Management Act, Finance Instructions 2010 and Finance (Amendment) Instructions 2016, and for such internal control as the management determine is necessary to enable the preparation of financial statements that are free from material misstatements, whether due to fraud or error.

Auditor's Responsibilities

My objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISA will always detect a material misstatement when it exists. Misstatements can arise from fraud and error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of the financial statements.

Loss of Revenue

The Ministry recorded a loss of \$3,827 for the financial year ended 31 July 2017. This consist of outstanding unretired Accountable Advances which is money owed by a former employee of the Ministry. The matter has been reported to FICCAC for further investigation.

Loss (other than money)

Board of Survey for Ministry of Sugar Industry was carried out in the month of June 2017, covering the period for August 2016 to July 2017. There is loss of assets valued at \$2,926 for the year ended July 2017 as follows:

NOTE 1: REPORTING ENTITY

The Ministry is responsible for implementing key policies and plans consistent with Government programs to achieve higher economic growth whilst ensuring tangible sustainability of Fiji's sugar industry. On-going partnership with the relevant industry stakeholders does provide a strong platform to encourage increased cane production, adequate labor and committed sugar workforce.

The establishment of a dedicated Ministry of Sugar Industry provides at the enabling environment for direct efficient delivery of services to the stakeholders and cane districts and sectors throughout the cane belt. The adoption of the 'professional' service delivery by the Ministry will promote maximum cane and sugar production annually through increased investments in cane and mill efficiency operation which lead to high quality sugar for export to existing and potential markets.

Through the grant assistance to the relevant sugarcane institutions, the Ministry delivers the following services to the sugarcane growers by way of fertilizer subsidy, cane variety research, effective administration of cane contracts, upgrading of cane access roads, cane planting and replanting assistance and GIS mapping of cane farm.

Furthermore, Government sourced funding within its budget to provide assistance to cooperative to procure mechanical harvesters.

Government is fully committed to the revival and future viability of Fiji's sugarcane industry.

Note 2: STATEMENT OF ACCOUNTING POLICIES

(a) Basis of Accounting/Presentation

In accordance with Government accounting policies, the financial statements of The Ministry is prepared on cash basis of accounting. All payments related to purchases of fixed assets have been expensed.

The financial statements are presented in accordance with the Financial Management Act and the requirements of Section 71(1) of the Finance Instruction 2010. The preparation and presentation of a Statement of Assets and Liabilities is not required under the current Government policies, except for that of the Trading and Manufacturing Accounts.

MINISTRY OF SUGAR INDUSTRY NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS (continued) FOR THE YEAR ENDED 31 JULY 2017

(b) Accounting for Value Added Tax (VAT)

All income and expenses are VAT exclusive. The Ministry on a monthly basis takes out VAT output on total money for expenditure from Ministry of Economy. VAT input on the other hand is claimed on payments made to the suppliers and sub-contractors for expenses incurred.

The VAT payments as per the statement of receipts and expenditure relates to the VAT input claimed on payments made to the suppliers and sub-contractors for expenses incurred and VAT payments to FRCS. Actual amount paid to FCRS during the year represent the difference between VAT Output and VAT Input.

(c) Comparative Figures

Where necessary, amounts relating to prior years have been re-classified to facilitate comparison and achieve consistency in disclosure with current financial period amounts.

For the purpose of comparison of results for the twelve (12) months period covering from August 2016 to July 2017, the corresponding result for the previous financial period (fiscal 2016) can be prorates by dividing the respective figure by twelve (12) and multiplying by seven (7).

NOTE 3: SIGNIFICANT VARIATIONS

- (a) The increase in Travel and Communications by \$79,044 or 210% was attributed to the increase in local and international travel for the year ended 31 July 2017.
- (b) The decrease in Special Expenditures by \$74,680 or 34% was due to the reduction in funds given to Sugar Industry Tribunal for the operation costs relating to the GIS Cadastre Development.
- (c) The decrease in Capital Construction by \$2,476,447 or 90% was due to the transfer of funds from SEG 8 to SEG 10 for the Fiji Sugar Corporation to upgrade Cane Access Roads. This role was previously carried out by the Ministry.

A total virement of \$44,124 was made for SEG 3 to cater for the Permanent Secretary's local and overseas for meetings. The virement was for future planned expenditure since the Ministry had utilized the allocated budgeted amount of \$88,000. The Ministry did not fully utilize these funds.

Virement into SEG 4 was to facilitate payment for hire of vehicles from Ministry of Works for the engagement of Fiji Corrections Service for cane cutting exercises in Rakiraki.

Virement into SEG 5 was made for the purchase beds and television for the Fiji Correction Services inmates for the cane cutting exercise and for Prime Minister's consultation. The Prime Minister's consultation was cancelled due to bad weather resulting unutilized funds. The decrease in SEG 8 by 2,723,325 was due to the transfer of funds from SEG 8 to SEG 10 for the Fiji Sugar Corporation to Upgrade Cane Access Roads. This role was previously carried out by the Ministry.

Virement of \$3,419,424 into SEG 10 was to transfer funds to Fiji Sugar Corporation in the form of Capital Grants to administer the upgrading of Cane Access Roads. This role was previously undertaken by the Ministry.
